If you donated to any arts, heritage or humanities nonprofits in Oregon this year, you are eligible to direct a greater portion of your taxes— taxes you're going to pay anyway— to support cultural projects in the state with the Cultural Tax Credit.

Here's how:

- 1 Total what you donated to qualifying Oregon cultural nonprofits during the calendar year. Scan to see the full list.
- 2 Circle the corresponding range below and how you plan to file your taxes this year. The intersection of the two is the recommended contribution to the Cultural Trust in order to maximize your cultural giving and receive a 100% tax credit. Contributions from your IRA and gifts of stock are welcome and qualify for the tax credit.

- 3 Give to the Oregon Cultural Trust online at culturaltrust.org or by mail by December 31.
- 4 Get your Trust donation back as a tax credit when you file your taxes.
